# Overcoming Barriers to Childcare for Children with a Disability/Complex Needs

Overview of 2012/13 Funding Initiatives



#### **Objectives**

- To increase availability of high quality childcare available for parents of disabled children
- Remove barriers for children with disability to access childcare;
- To facilitate parents of children with a disability/complex needs to return to work/education/training.



### Issues highlighted during scoping

- Inability to find childcare provider who is able to offer the level of specialist support that child requires;
- Lack of flexibility to accommodate childcare requirements which may change on a regular basis;
- Lack of specialist equipment/accessibility requirements;
- Childcare is cost prohibitive as child requires one-to-one care which requires employment of specialist staff, or reduces the number of children a childminder can look after;



#### Cont'd

 Parents lack confidence to leave their child with in childcare as they do not believe that it will be able to meet their particular needs.



#### **Funding Bid**

- bid for £500k per annum over 3 years
- £150k allocated for 2012/13
- Additional £350k available immediately in 2013/14
- Further £1m available subject to positive evaluation of 2012/13 funding.



## 2012/13 Pilot Schemes

#### **Small Grant Scheme**

- Up to £2k available for childcare providers, £1k to childminders;
- To by used to pay for/contribute towards the cost of specialist equipment or small adaptations.

#### **Children's Disability Training Programme**

 CiNI funded through addendum to HSC Board contract to deliver range of children's disability training;



# **Small Grants Scheme**



#### **Funding criteria**

- Additional staff costs <u>not</u> eligible;
- Applicant service must be registered with local Trust Early Years Team, and offering a service to children between 0-12 years.
- Applicant service must currently provide childcare to a child/children with disabilities, or must have children with a disability waiting to access childcare.



### **Funding criteria contd**

- Application demonstrates that the service provides an inclusive environment for children with disabilities;
- Application outlines the nature of the disability of referred child/children – and how the funding will support positive outcomes for the child and the setting.
- Service is verified by the Trust as providing a quality service and continuing to meet all Trust Registration Requirements



#### **Funding criteria contd**

#### **Eligible Costs:**

- Specialist equipment aimed at supporting children with a disability;
- Other equipment that will improve the quality of care/outcomes for children with a disability;
- Adaptation to premises aimed at improving the experience of children with a disability.



#### **Funding Summary**

- 91 applications were received
- 65 of those applications were successful
- 26 applications were unsuccessful
- 6 applications were rejected as they did not meet the initial criteria
- 20 of the applications did not meet the scoring threshold




# **Funding Summary Contd**

- A total of £106,432.92 was requested by successful applicants.
- £95,627.10 allocated by assessment panel.




# Geographical spread of applicants








#### Early Years Providers - Disability Grant Scheme - March 2013

- To increase capacity/expertise within the childcare sector.
