3 main sites: 2007-2013:Young Ballymun; Northside Partnership and the Childhood Development Initiative in Tallaght

To Implement a strategy of integrated, evidence-based prevention and early intervention supports for children, young people and families.

Followed by the ABC initiative

An area-based approach to child poverty, drawing upon best international practice and existing services, to break the cycle of child poverty where it is most deeply entrenched.

2013-2016 with a budget of €29.7m. This Initiative is building on and continuing the work of the Prevention and Early Intervention Programme (PEIP) which supported projects in Tallaght, Ballymun and Darndale.

9 areas have been selected to enter the design stage.


- All major organisations and agencies working locally on behalf of children and young people are to be represented on the CSCs.
